TOWN MANAGERS REPORT

First of all, Mike Majher wanted to acknowledge the loss of Adrian O'Connor. Adrian was a significant member of the community. He will be missed and it will be difficult to fill the gap that his passing has made.

Town Manager Mike Majher reported:

- 1. It has been very busy with INI studies and repairs on the area we think is the source of the flow problems.
- 2. Zoning Permits are nonstop. 83 permits were issued in January.
- 3. The CVS Fruit property fire had us busy trying to figure out who now owns it. No one will admit to owning it. They already owe \$3000 in back taxes, and we will now be adding a bill for the work that our Public Works department had to do.
- 4. Newtown History Museum has informed us that they are trying to get the Minnick Zirkle freightwagon that is in Williamsburg. This wagon is one of the only wagons left that was made in Stephens City. It would not be given to the Town but would be a long term loan.
