#### TREASURER'S REPORT - Report attached

#### POLICE REPORT - Report attached

Chief Copp asked if there were any questions about the report. The Easter Egg Hunt at The Commons went smoothly with a record crowd. The Chief invited Police Officer to speak to Council on a case that he had been working on. Officer Nauman informed that he had been working on a case at Freedom Ag, formerly Southern States, for three weeks and an arrest had been made. The accused are facing charges on multiple counts. He explained that this is an ongoing investigation that involves more than just the individuals arrested in this area. The investigation is far reaching

from Miami, Florida to Elizabeth, New Jersey. Chief Copp wanted to give Evelyn Partlow (Admin. for the Department) a pat on the back for all her help during this investigation. Councilor Fravel commented that in an email from the Virginia Fusion Center it was noted as a success story.
