WHEREAS, the Council of the Town of Stephens City, Virginia has convened a closed meeting on this date pursuant to an affirmative recorded vote and in accordance with the provisions of the Virginia Freedom of Information Act; and

WHEREAS, Section 2.2-3712.D of the Code of Virginia requires a certification by this Council that such Closed Meeting was conducted in conformity with Virginia Law,

NOW THEREFORE, BE IT RESOLVED that the Council hereby certifies that, to the best of each member's knowledge, (i) only public business matters lawfully exempted from open meeting requirements by Virginia law were discussed in the closed meeting to which this certification resolution applies, and (ii) only such public business matter as were identified in the motion convening the closed meeting were heard, discussed or considered by the Council. Town Council entered Closed Session at 7:19 pm and came into Open Session at 8:23 pm.

RESOLUTION TO APPROVE SETTLEMENT AGREEMENT

A motion was made by Vice Mayor Nauman to adopt the following resolution.

- 1. Whereas, the Town of Stephens City and the Frederick County Sanitation Authority (now trading as Frederick Water) have been engaged in water and wastewater services for many years;
- 2. Whereas, the parties have had multiple disagreements during those years which led to litigation between them;
- 3. Whereas, the Town and the Frederick Water voluntarily entered into mediation in an effort to resolve the pending litigation and address other issues. The Town Council appointed Council members Linden "Butch" Fravel, Jason Nauman, and Town Manager Mike Majher, along with counsel to negotiate on

their behalf. Frederick Water was represented by Board members Gary Oates, Tom Simon, and Executive Director Eric Lawrence, along with their counsel.

- 4. Whereas, on October 9, 2018 the Town's mediation representatives and the Frederick Water mediation representatives approved the term sheet ("Final Term Sheet Between the Town of Stephens City and Frederick Water") dated October 9, 2018 that would resolve the parties' differences, result in the dismissal of the Town's lawsuit and Frederick Water's counterclaim suit, as well as generate substantial benefits for both parties and the customers they serve. Frederick Water's Board on October 16, 2018 approved the Term Sheet, and the Town of Stephens City's Council on October 23, 2018 approved the Term Sheet,
- 5. Whereas, the Term Sheet calls for a detailed agreement between the parties to implement this resolution, and the parties have worked since October 23, 2019 to craft language acceptable to all to resolve their differences in accordance with the Term Sheet,
- 6. Whereas, the Town of Stephens City understands that the Frederick Water Board met earlier today and approved the joint agreement,

NOW THEREFORE, BE IT RESOLVED that the Town of Stephens City Virginia's Common Council approves, conditioned on and based upon the prior approval by the Frederick Water Board of the exact same document presented here known as the Settlement Agreement between Frederick Water and the Town of Stephens City dated May 7, 2019 and authorizes Linden "Butch" Fravel to sign the Agreement on behalf of the Town.

ORDINANCE TO REPEAL PUBLIC WATER SUPPLY PROTECTION DISTRICT

AN ORDINANCE TO REPEAL THE TOWN'S PUBLIC WATER SUPPLY PROTECTION DISTRICT, ALSO KNOWN AS THE GROUNDWATER PROTECTION ORDINANCE.

BE IT ORDAINED, by the Common Council of the Town of Stephens City, Virginia, that Article IV Chapter 22 of the Town Code known as the Public Water Supply Protection District is hereby repealed in its entirety, in conformity with the agreement reached with the Frederick County Sanitation Authority.
