Report of the Fire & EMS Chief August 2020

Report of responses for July 2020

Town of Stephens City:

Fire- 3 EMS- 15 MVC- 0 Frederick County:

Fire- 26 EMS- 165 MVC- 12

Total responses for July 2020: 221 Yearly response total as of July 31, 2020: 1461

- Frederick County Fire & Rescue Chief Dennis Linaburg announced his retirement from the department effective January 1, 2021. It is expected that Assistant Chief Majchrzak will be appointed to fill the role and a subsequent competitive process will be held to fill the assistant chief role.
- Sergeant Matt Caplan has applied for and received confirmation of award for an Assistance to Firefighters Grant (AFG) to outfit our station with an exhaust removal system. For those not familiar, this system attaches to the exhaust of the apparatus and prevents, or greatly reduces, the exhaust gases and particles from escaping into the apparatus bays where it is deposited on surfaces and structural firefighting gear stored in lockers. Health studies have shown that this exposure over time contributes to the cancer rate in first responders. This system will aid us in the endeavor to lower first responder exposure to carcinogens. As you can imagine, this grant is of high priority for the AFG program. As such, this grant was awarded at \$99,000 total with a small 'matching' portion provided by the department which is estimated at \$5,000. This leaves the AFG funded portion at approximately \$95,000. Planning has already begun on the installation of this system.
- The MOU between Frederick County, Stephens City Fire and Rescue, and the Virginia Department of Emergency Management (VDEM) for swiftwater services has been signed by the Operational Medical Director of VDEM, executed, and is currently active. There was no statewide deployment for Tropical Storm Isaias and no local requests for water rescue thus far because of the storm.

Purposes/Subjects to be reviewed:

1. Special Use Permit Application 01-20 Stephens City Truck Services

- 2. Zoning Permit/Variance 19-20 Clem's Garage
- 3. Discussion: Planning review of Town Floodplain Ordinances

Brief of Committee Actions and Recommendations:

1. Stephens City Truck Services has applied for a Special Use Permit. They would like to create a parking area for up to 40 trucks and if demand was great they would increase the amount of spaces. Paul Culp asked what the maximum amount of spaces would be. Mr. Singh said anywhere between 100 and 150. Bob Wells wanted to know if these trucks would be running all night and if there was a set fee for the night. Mr. Singh informed the commission that there would be no set fee, the spaces would be rented out weekly or monthly. He also said that the trucks would not be running unless they are refrigerator trucks. The only thing that would be running is the generator that keeps the refrigerator on. The spaces are for overnight parking, catering to local drivers. Darryl Bell voiced his concerns that having this type of business would affect the downtown area and would deter businesses from coming into Stephens City. Bob Wells was wary of bringing more traffic to that area, stating that the traffic light is already a mess with the amount of traffic we already have. Mr. Fravel suggested that there be a limit of 30 spaces and if necessary, they could come back at a later date to request more. Mr. Fravel asked if this Special Use Permit would be tied to the business or the owner. Mr. Majher informed the Commission that it would be tied to the owner. After much discussion the Commission felt that

they needed more input from the public. It was also suggested that there be a joint planning meeting with council.

Paul Culp made the Motion that there be a Public Hearing on August 25th to discuss the Special Use Permit. Bob Wells seconded the Motion. The Motion passed with the following VOTE: Aye-L. Fravel, Culp, Dilg, Wells

2. Billy Clem has asked for a Zoning Permit/Variance. He has asked for the variance to be able to put in an access driveway at the bac of his property. This access would give Clem's Garage a back access to their business. This would be a gated service entrance for their service vehicles. Mr. Clem stated that VDOT had already signed off and it was all in line with their Specs. Bob Wells thought that this would be safer for the drivers for the business and for the town's traffic. Darryl Bell agreed with that.
