







From the Desk of the Mayor

FROZEN WATER LINES

It's that time of year! This is when most homes experience frozen water lines. Most of the time the first place to check for a frozen water line is an exposed drafty area beneath or within your home or business. Find and be aware of where the cutoff valve is within your home. Town water meters are insulated and are not prone to freezing. Do not open a water meter box unless you have contacted the Town and been given permission.
